



# ACTIVE PATHWAYS SUBSIDISED MEMBERSHIP

Peninsula Leisure are proud to offer the Active Pathways subsidised membership program in partnership with Reclink Australia, to provide inclusive pathways to improved health and wellbeing for individuals experiencing disadvantage in the City of Frankston.



## **MEMBERSHIP OPTIONS**

Peninsula Leisure offer the following membership options at heavily subsidised rates for approved applicants:

### 16 - 25 YEARS OF AGE

PARC 3-month Full Access Active Pathways membership, or Pines 10 Visit pass Aquatic

### **26 YEARS OF AGE & ABOVE**

PARC 3-month Full Access Active Pathways membership, or PARC 3-month Aquatic Access Active Pathways membership, or Pines 10 Visit Pass Aquatic

## ELIGIBILITY

To be eligible for Active Pathways, participants must:

- reside within the City of Frankston
- be 16 years of age or over
- be referred to the program through a support agency
- be approved for the program by Reclink Australia

## RENEWAL CRITERIA FOR MEMBERSHIP

Eligible participants can renew their membership for an additional 3 months by demonstrating the following criteria at the conclusion of their current membership:

- still residing in City of Frankston
- attended minimum of 10 times in past 3 months
